ASSET In-State Tuition Application

To qualify for Colorado ASSET In-State tuition a student must:

- Have attended a public or private high school in Colorado for at least three years immediately before graduation or completion
 of a general equivalency diploma (GED) in Colorado. Three years is defined as six academic terms from three separate
 academic years immediately preceding graduation or completing the GED.
- Be admitted to a Colorado college/university within 12 months of graduation from a Colorado high school or completion of a Colorado GED, graduated from a Colorado high school or completed the GED before September 1, 2013 and have continuous presence in Colorado for 18 months preceding the start date of classes.
- Complete the affidavit with the College Opportunity Fund indicating that you have applied for legal presence or will apply as soon as you are eligible to do so.

To be considered for ASSET you must submit this application along with the following documents:

- Final Colorado high school transcript(s)
 - o Colorado high school transcript must show at least three years of attendance and graduation date
 - Unofficial transcripts acceptable
- Colorado GED transcript, if applicable
- COF affidavit confirmation (please complete COF application at: https://cof.college-assist.org/)
- Documentation that you were admitted to a Colorado college/university within 12 months of graduating high school or completion of GED
 - Students who graduated before September 1, 2013 and were not accepted to a CO college/university within 12 months of graduation need to provide proof of 18 months of continuous presence in the state of Colorado. Please provide as many documents as possible from the following list:
 - Copy of lease or rent receipts
 - Homeowner warranty deed
 - Colorado ID or driver's license
 - Proof of employment
 - Signed copies of Colorado income tax return
