

The Colorado Revised Statute (C.R. S 23-7-101 et. Seq), CCHE regulations, and State Attorney General Guidelines require anyone claiming in-state tuition to have been domiciled in the state for at least one year prior to the first day of classes. The purpose of this petition is to determine in-state tuition status.

- Students over 23 Complete the petition and provide documentation needed for **Domicile** and **Intent**.
- Students under 23 whose parents or legal court appointed guardians are Colorado residents Complete the petition and provide Domicile and Intent documentation for your biological parents or
  legal court appointed guardians. If you have a legal court appointed guardian, you must provide court
  documents.
- Students under 23 who have been married for over one year Marriage to a CO resident does not by itself qualify for in-state tuition status. Complete the petition and provide documentation under the *Domicile* and *Intent* areas below. Also provide a copy of your marriage certificate. Emancipation documentation is not required.

### **Evidence of physical presence (Domicile) (Must provide 1)**

- Proof of Colorado mortgage / lease / notarized letter of current residence
- Proof of Colorado state income tax for the past 18 months prior to the first day of class

### **Evidence of Intent (Must provide 1)**

- Proof of Colorado motor vehicle registration
- Proof of Colorado driver's license or identification
- Proof of one year employment in Colorado

#### **Evidence of Emancipation**

- Proof of marriage License if married for one year
- Proof of Individual's Federal income tax covering the year of emancipation (Form 1040)
- Proof of monthly bank account statements, trust account statements, any other type of account statements, or proof of income source covering the year of emancipation – used to determine how you support yourself without parental support

#### Military (Submit all documents from the list below if applicable)

- Provide a copy of Form DD 214 if discharged from military service
- Provide a copy of Leave and Earnings Statement (LES) if you are on active duty during the past 12 months

### ASSET - Students must complete the Colorado ASSET form

Students who have attended at least 3 years and graduated from a Colorado high school, and applied to or attended a Colorado college within 12 months of graduating high school.
