



## Procedures for Requesting Colorado ASSET In-State Tuition

### **To qualify for Colorado ASSET in-state tuition a student must:**

- Have attended a public or private high school in Colorado for at least three years immediately before graduation or completion of a general equivalency diploma (GED) in Colorado.
- Be admitted to a Colorado college or university within 12 months of graduation from a Colorado high school or completion of a Colorado GED.
- Complete an affidavit with the College Opportunity Fund indicating that you have applied for legal presence or will apply as soon as you are eligible to do so.

### **ALL ASSET STUDENTS:**

- Submit an Emily Griffith Technical College ASSET Application with supporting documentations.
- Submit unofficial, final Colorado high school transcripts indicating three years of attendance at a Colorado high school immediately before obtaining your Colorado high school diploma or Colorado GED.
- Submit unofficial Colorado GED transcript, if applicable.
- Submit proof of acceptance to a Colorado college or university (institutions other than EGTC) within 12 months of graduation from a Colorado high school or completion of a Colorado GED.

**For students who graduated or took the GED prior to September 1, 2013 and weren't accepted or attending college within twelve months of graduation must document eighteen (18) months of physical present in Colorado on a continuous basis.**

Submit copies of any relevant documents such as:

- Rental/Lease agreements
- Proof of home ownership (mortgages)
- Proof of employment (W2 or check stubs)
- Signed Copies of Colorado income tax return
- School transcripts
- Vehicle Registration
- Insurance policies
- Bank Statements with Colorado address
- Hospital or medical records
- Official records from religious entity in Colorado (e.g., baptism, wedding)
- Military records

NOTE: In all of these documents, your name and the name of the interested organization must appear on the form or letter, as well as relevant dates. Letters must include your address.

\_\_\_\_\_ Documentation that you were admitted to a Colorado college/university within 12 months of graduating high school or completion of a GED, if applicable

\_\_\_\_\_ 18 months continuous physical presence in Colorado documents, if applicable  
*If you graduated a Colorado high school or completed a Colorado GED before September 1, 2013 and you were not accepted to a Colorado college/university within 12 months of graduating/completing a GED, you **MUST** submit proof of 18 months continuous physical presence in Colorado.
